DATA PROTECTION – our approach

You should be aware that a record is kept of all donors and supporters on the basis of the information that you supply, excluding any details which might be deemed sensitive.

This information is required for audit and Gift Aid purposes and is recorded in a password-protected 'Word' document, held on the Team Google Drive, accessible to the Fundraising Officer only. It is not put into a database or similar listing, manipulated, passed to any other organisation, or used for any other purpose beyond the support of the Duddon & Furness Mountain Rescue Team. A copy is downloaded monthly onto a memory stick, and locked in a safe, to ensure that information is not lost.

We will not contact you by telephone, text or e-mail for direct marketing but may occasionally use e-mail or telephone to resolve a query, to pass on our thanks or when you have offered active support. Our main method of communicating with you will be by letter, which will be individually produced, usually including our newsletter. Following a single donation, or occasional support, we may contact you on one or two occasions. If you do not contact us in response we will cease to contact you again and your details will be removed from the computer document. Paper and secure electronic password-protected details (memory stick in safe) are normally retained for 7 years, along with Gift Aid certificates.

If there is anything in the above that you do not agree to or if you prefer that we do not retain your details or contact you again – please let us know and your details will be removed from the current computer record.
